- It has been a strange fall; we are happy to be back and settled after job action and the Fall Break.
- The job action that took place in October has brought the topic of student funding to the forefront of the media.
- Schools are in unfortunate positions in which they often must choose between class sizes and extra help with education assistants—they can't afford both.
- Annie Gale has class sizes which range from 27 to 33 and those are relatively small, in comparison to some other schools. However, the trade off is that we only have one education assistant to support the entire school. This means that out of 120 classes in every day, our education assistant can support only six classes.
- ATA members, which consist of teachers and school administrators, have been asking parents and guardians to reach out to their MLAs to discuss per student funding as well as any additional concerns that they might have.
- We recently learned of some funding coming to the school to support social/emotional learning; in December we will announce how this funding affects classes and supports in the school.
